No. DME-18/1/2026-HEALTH: It is for general information to all concerned that candidates who have qualified in NEET-UG 2026 can participate in "the Manipur Medical e-Counselling 2026-27" for allotment of the following seats:

- A. State Government seats for MBBS/BDS/BASLP courses at RIMS, JNIMS, Shija Academy of Health Sciences (SAHS), Churachandpur Medical College (CMC), Regional Dental College (RDC) Guwahati.
 - B. Management quota seats for MBBS course at Shija Academy of Health Sciences (SAHS).
 - C. NRI quota seats for MBBS course at Shija Academy of Health Sciences (SAHS).
2. The entire counselling process will be conducted strictly in ONLINE MODE through the dedicated online portal at <https://manipurmc.mn.gov.in>
 3. Eligible Candidates shall compulsorily register in the web-based application available at <https://manipurmc.mn.gov.in> to participate in the "Manipur Medical e-Counselling 2026-27" as per schedule given below:

4. Link to the online portal is also available on the website <https://manipurhealthdirectorat.mn.gov.in>.
5. Candidates shall carefully read the "SOP for Registration and 1st Round of counselling" given in Annexure-A. "Technical Instructions for Registration" and "Seat matrix" shall be notified soon.
6. Registration will be complete only after payment of the following 02 (two) kinds of Fees:
 - a. Non-refundable Application Fees as follows:
 - i) ₹2000/- (₹1500/- for ST and SC candidates) for State Government seats.
 - ii) ₹2000/- for Private (Management & NRI quota) seats at SAHS, Langol.
 - iii) ₹4000/- (₹3500/- for ST and SC candidates) for both Government and Private (Management/NRI quota) Seats.



- b. Refundable Security Fees of ₹ 15000/- (Rupees Fifteen Thousand Only) for all categories.

This amount shall be refunded after completion of all rounds of counselling, subject to fulfilment of relevant conditions.

7. Registration in the web-based application will be allowed before every Round of Counselling. Candidates who have registered for any round of counselling need not register again for further rounds. "Choice Filling" in the web-based application will be mandatory for every round of counselling. "Choice of seat" filled in any round will not be valid for further rounds.
8. Further communication regarding the Counselling process will be done only through (i) SMS to the registered mobile number & (ii) notifications on <https://manipurmc.mn.gov.in>, and (iii) notifications on www.manipurhealthdirectoriate.mn.gov.in. official website

ANNEXURE

SOP for Registration and 1st Round of counselling

A. Registration

1. Qualified and eligible candidates are required to register in the web-based application <https://manipurmc.mn.gov.in> , to participate in the counselling process for allotment of seat. Directorate of Medical Education (DME) does not allot any seats manually.
2. Registration through any other mode is not allowed.
3. A candidate can submit NEET-UG Counselling application/registration form for State Counselling only once. Any candidate found to have submitted more than one application/registration form for NEET-UG Counselling shall be debarred from NEET-UG Counselling allotment process, his/her candidature shall be cancelled.
4. A candidate can choose from 3(three) Seat types namely, Government (RIMS, JNIMS, CMC, SAHS-Govt. quota, RDC), Management (SAHS Management) and NRI (SAHS NRI) at the time of registration. Multiple choices are allowed subject to payment of relevant fees. Once final submission is completed, seat type selections are **permanently locked**. Re-categorization, modifications, or alteration requests are **strictly prohibited** across the current and all future counselling rounds without exception.
5. Refundable Security Fees will be forfeited if a candidate fails to join the Institute in the Second or subsequent rounds within the stipulated joining time. Also, Refundable Security Fees will be forfeited if the admission gets cancelled for any reason. E.g., if the candidate gives wrong information at the time of registration, based on which a seat may be allotted, and the admission is later cancelled by college authorities.
6. Candidates shall undertake and declare that the information given at the time of registration is correct and complete to the best of his knowledge and, he may be prosecuted under any court of law for wilfully submitting wrong information or suppressing material facts, if there is any.
7. No candidates shall be allowed to change/alter their existing data of NEET UG 2026 (as received from the Medical Counselling Committee, DGHS, Govt. of India) at the time of registration.
8. Information regarding fee structures may be had from the colleges concerned before filling in the "Seat Choices".
9. Candidates may lock their "Seat Choices" within the stipulated timeline after which they cannot be modified. Even if the "Seat Choices" are not locked by the candidate, it will be auto-locked at the end of the stipulated timeline.



10. Any updates on the "Schedule / latest updates / Results / Notices / News & Events regarding the online counselling" may be had from the DHS website www.manipurhealthdirectorates.mn.gov.in or the web-based application <https://manipurmc.mn.gov.in>.
11. The DME reserves its absolute right to alter, amend, modify, or apply any or some of the instructions/ guidelines. In case of any ambiguity in the interpretation of any of the instructions/ terms/ rules/criteria, the interpretation of the DME shall be final and binding in nature.
12. Candidates must ensure that mobile numbers and e-mail ID filled at the time of Registration are their own or their Parents'/guardians' only, as DME will communicate only through SMS or e-mail on the given mobile number and e-mail ID. DME will NOT be responsible for any incorrect credentials. Any complaint with regard to the change of registered mobile number or email address shall not be entertained by the DME.
13. Applications once submitted cannot be withdrawn. Mere deduction of fees from the bank account is not a proof of fee payment. Acknowledgement slip of Registration is the confirmatory proof for fee payment.
14. Registration in the web-based application will be allowed before every Round of Counselling. Candidates who have registered for any round of counselling need not register again for further rounds. "Choice Filling" in the web-based application will be mandatory for every round of counselling. "Choice of seat" filled in any round will not be valid for further rounds.
15. Refund will be processed as per counselling Scheme once all the rounds are completed.

B. First Round of Counselling

1. Main Counselling Registration which will include payment of Non-Refundable Registration fee and Refundable Security Deposit (to be refunded only in the account from which payment has been made).
2. Exercising of choices and locking of choices during choice filling/ locking window to be done as per the schedule.
3. Process of Seat Allotment: Seat allotment shall be done based on Manipur Medical MBBS/BDS/BASLP (Selection of Candidates for Nomination) Rules, 2021 and its Amendment Rules, 2025.
4. Publication of result of Round-1 on the official website www.manipurhealthdirectorates.mn.gov.in and issue of allotment letter to the allotted candidates on the online portal.
5. Allotted Candidates shall download the "allotment letter" from the web-based application <https://manipurmc.mn.gov.in>.



6. Candidates shall be required to choose their preference of either "FREEZE" or "FLOAT" to proceed further. Further change after confirmation shall not be allowed in any case.
7. Physical Reporting with original documents at the allotted Medical/Dental College against Round-1 for candidates who do not want upgradation (FREEZE CANDIDATES).
8. Candidates who want to upgrade their seat in further Rounds can give willingness for upgradation online. (FLOAT CANDIDATES). Such candidates do not need to physically report at the allotted college. They shall download the "Provisional Admission letter" from the web-based application <https://manipurmc.mn.gov.in> after due verification by the respective Institutes. However, candidates allotted seats in the Regional Dental College (RDC), Guwahati shall mandatorily report physically to the Institute for verification of original documents and completion of admission formalities. The provisions relating to Online Verification and Online Provisional Admission shall not apply to such candidates.

C. Process for Seat Withdrawal (Resignation)/ Surrender Process for Candidates allotted in First Round of Counselling.

The process of resignation/ seat surrender based on willingness of candidate will be as follows for Freeze/ Float Candidates:

1. FREEZE CANDIDATE- will have to visit physically to the allotted institute for resignation

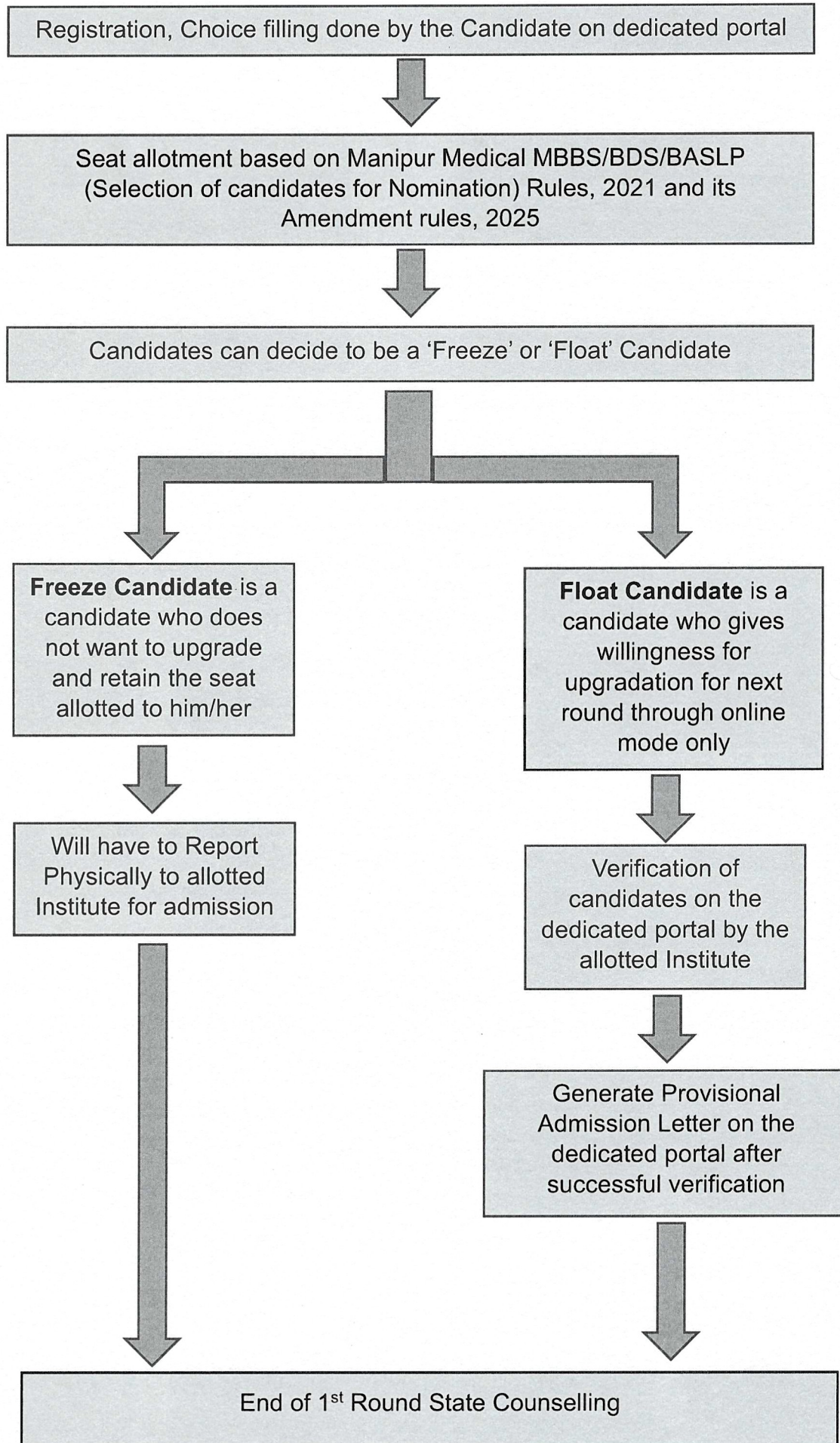
- a) Candidate will physically report at the allotted institute and submit Resignation within stipulated time period prescribed by DME to be eligible for next round of counselling.
- b) Once a seat is surrendered/resigned, candidate will have **NO** claim on that particular seat.

2. FLOAT CANDIDATE

- a) Candidates with provisional admission may submit an **online seat surrender** request in the prescribed template on the counselling portal within stipulated time period prescribed by DME.
- b) Once a seat is surrendered/resigned, candidate will have **NO** claim on that particular seat.

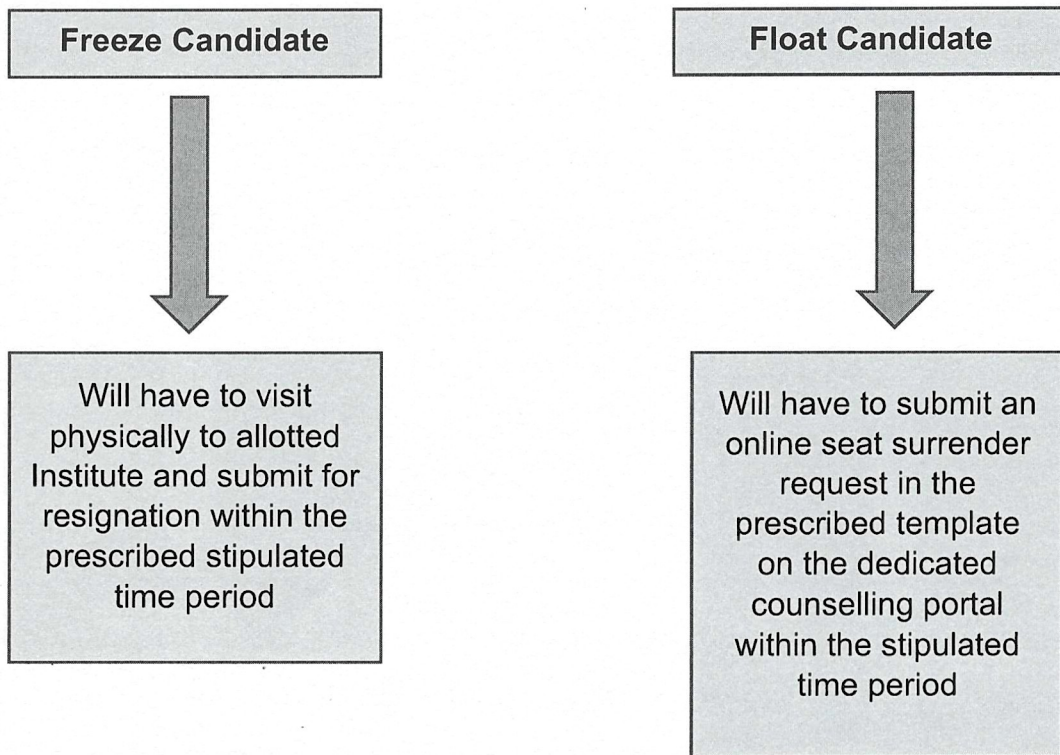


ONLINE STATE COUNSELLING SCHEME (1ST ROUND)
